**CAUTIONARY ANNOUNCEMENT** 

Trustco shareholders are referred to the announcement released on SENS on 23 August 2021 ("August

SENS Announcement") regarding the agreement ("Management Agreement") entered into between

Next Capital Ltd ("Next") and Trustco in terms of which Next has been appointed to provide the

management services as set out in the August SENS Announcement, to Trustco, for which Next shall

earn a fee from Trustco for the provision of such services ("Management Fee").

As per the August SENS Announcement, the Management Fee shall be calculated based on a number

of objectives and their relative performance including Shareholder Return Based Metrics where Next

shall be compensated via the issue of Trustco Shares should the share price of a Trustco share remain

at agreed levels, for a period of at least 90 days on a Volume Weighted Average Price basis

("Shareholder Return Based Metric Shares").

The entering into of the Management Agreement was classified as a Category 1 Related Party

transaction in terms of the Listings Requirements of JSE Limited ("Listings Requirements"). However,

the issue of the Shareholder Return Based Metric Shares has since been deemed to be a specific issue

of shares for cash as per paragraph 5.51 of the Listings Requirements. A circular therefore containing

the full details of the Management Agreement including the issue of the Shareholder Return Based

Metric Shares and incorporating a notice convening the required general meeting of Shareholders will

be distributed to Shareholders in due course.

The issue of the Shareholder Return Based Metric Shares requires the information as set out in

paragragh 11.20 of the Listings Requirements to be disseminated via SENS. As certain of the

information as required by paragragh 11.20 cannot be disseminated at this point, including the effects

of the issue on net asset value per share, net tangible asset value per share, earnings per share,

headline earnings per share, diluted earnings and headline earnings per share, Shareholders are

advised to exercise caution when dealing in the Company's securities until all of the information

required to be disseminated as per paragragh 11.20 of the Listings Requirements has been released.
